

CogLibris Supervision Terms of Agreement (Supervisees)

These terms apply to therapists enrolled in the ABCR or MCT training certifications (hereafter referred to as ‘supervisees’) who choose to receive supervision from an E-Cog supervisor. E-Cog supervision is a service offered by [CogLibris](#). By purchasing supervision from E-Cog/ CogLibris, you acknowledge that you have read, understood, and agreed to the terms outlined below.

1. Purpose of Supervision

Supervision sessions are offered to support the implementation and clinical integration of:

- **Action-Based Cognitive Remediation (ABCR)**
- **Metacognitive Training for Psychosis (MCT)**

Sessions provide space for discussion, case consultation, implementation planning, and Q&A. They are not designed to replace licensure-related supervision and are not approved by any regulatory body or licensing boards. **CogLibris provides two levels of certification through the E-Cog Platform:**

- **Online Training Certification:** Awarded upon successful completion of the online training program.
- **Therapist Certification:** Awarded following the successful completion of the required supervision component and supervisor approval.

2. Eligibility

Supervision is available to individuals who:

- Are currently enrolled or were previously enrolled in the **E-Cog ABCR or MCT certifications**.
- Have purchased either individual or package supervision options.

3. Supervisors and Allocation

Supervision is provided by **experienced therapists specialized in each intervention**.

- For **ABCR**, supervisors are drawn from the [E-Cog team](#) or from **Dr. Chris Bowie’s team**

- For **MCT**, supervision is provided by members of the [E-Cog team](#).
- Supervisors are matched to supervisees based on availability and expertise.

4. Format, Scheduling & Attendance

- Sessions are delivered via a tool selected by the supervisor (e.g., Zoom, Teams) based on their existing clinical practice.
- Supervisors will send meeting links directly to supervisees for each scheduled session.
- Supervision is delivered individually or in groups.
- A maximum of four supervisees can attend a group supervision session. If sessions were obtained as a package, the same group of supervisees (up to four), from the same team, are expected to join all the sessions in the package.
- Additional sessions may be acquired through the E-Cog website (based on supervisor availability) to ensure individual supervisee needs are met, or when extended team supervision sessions are required

5. Pricing, Payment & Validity

- **Current supervision rates:**
 - **\$200 CAD** per individual session, plus applicable taxes and fees.
 - **\$1,000 CAD** for a package of 6 sessions, plus applicable taxes and fees.
- Payment is processed directly through the E-Cog platform.
- Supervision packages and pricing are subject to change. The rates provided are valid for your current purchase and may not apply to future purchases.
- **Individual sessions** must be used within **six months** of purchase.
- Packages must be **completed within one year of purchase**.
- Purchased supervision sessions and packages are non-refundable.
- Expired sessions or packages may be reactivated upon payment of a reactivation fee equal to **30% of the original purchase price**, subject to supervisor availability. The possibility of reactivation is **not guaranteed**.

6. Cancellation, Rescheduling & Attendance

- Sessions must be canceled and rescheduled **with at least 24 hours' notice**.
- Missed sessions with less than 24h notice are **non-refundable**.
- No additional sessions are granted for absences.
- Supervision sessions are **not recorded**, and all shared information remains **confidential**.

7. Supervision Completion and Certification

- **A minimum of six (6) sessions is recommended to obtain the Therapist Certification**, but the total number remains flexible to adapt to the supervisee's needs and stage of development.
- The supervisor retains full discretion to determine whether a supervisee has demonstrated the competency required for Therapist Certification.
- **Additional Sessions:** If a supervisor assesses that a supervisee is not yet competent after the initial six sessions, the supervisee may be required to complete additional sessions to become eligible for certification.
- Purchase of additional sessions is at the discretion of the supervisee.

8. Disclaimers and Responsibilities

- CogLibris supervision through the E-Cog platform **does not substitute professional clinical supervision** required by regulatory bodies or licensing boards.
- Supervisors do not assume clinical responsibility for supervisees' clients.
- For professionals registered with the **Ordre des Psychologues du Québec (OPQ)**, supervision sessions conducted through E-Cog with our licensed psychologists may be eligible to count toward required supervision hours (formation continue), subject to OPQ approval and applicable regulations. An agreement between the supervisee and supervisor must be made prior to the start of the E-Cog supervision. Supervisors have the right to refuse such agreement.
- CogLibris does not assume responsibility or liability for the conduct, decisions, or outcomes of supervisors and supervision sessions, including any clinical interactions between supervisees and their clients. All supervision and clinical activities remain under the sole responsibility of the supervisors and supervisees, in accordance with their professional standards and applicable regulations.
